**Flathead National Forest** – Toby Thompson - Sold another 526 ac timber sale on the Dayton project. GNA (House Bill 883) Flathead National Forest generated \$6 million in applications with \$3m approved on the FNF, now looking at GNA capacity building to implement restoration projects. Keystone agreement with NFF- finalized agreement \$3.6m work on the Flathead NF, position out for advertisement to work with the NFF to be the Flathead project coordinator to manage projects. Joint Chiefs- in 3<sup>rd</sup> year with NRCS, Flathead NF out for bid IDIQ 850 (work) + 250 acres (optional work). Keystone agreement > NFF is the congressionally designated non-profit, but the NFF can solicit on their behalf, they can administer work on the FNF and the adjacent private lands. Allows for flexibility and is tied to the Wildfire Crisis Strategy (WCS) and Bipartisan infrastructure Law (BIL) funding that has been designated for keystone partners (ref graphic below...) to increase pace and scale of forest and fuels management on NFS managed land.

Conversation about contractors and "the list". How do contractors get on the list for different projects? State, NF, NRCS, MWED, private landowners? This has been a topic of discussion for a long time, and we could follow up. Post meeting, we talked about pushing out a survey to contractors that would populate a spreadsheet with > Name / contact information / location / description of specialty or preferred work (job size, type) / insured for what / ALP certified / can burn piles... We should work with a local contractor to build this survey to populate the spreadsheet to share. Ali is asking about support for this as well.

**Flathead Ridge Ranch** – Caleb Dietz, is working near Bitterroot Lake and connecting landowners with NRCS.

**NRCS** – Parker – They are going through 'Act Now" IRA funding and getting ahead of the curve for Bitterroot (still going) and Ashley Lake (final year), should have \$\$ by March, a lot of JC applications this year/final year (Haskill Basin, N and SE of Kila). Working on a plan to apply for another JC for FY25.

**Montana West Economic Development (MWED)** – Couldn't make the meeting, working on Haz Fuels funding in a couple of areas (Reservoir Road, Good Creek, Many Lakes, Kila, Somers, Lakeside...) and the WUI grant out on Foothill Road. Will be receiving HB883 funds for area SW of Kalispell and perhaps continue the work on Foothills.

**Flathead Electric** Amanda Opp "all things vegetation management" Swan Lake Feeder project is moving forward from Bigfork down the Swan. Vegetation management also addressing Ashley Lake/ Marion driven by lightning strike potential and fuels in the area. Receiving a grant (one of 3 applied for) should know more in March.

 Richard Hildner, question about vegetation management plans for the base of Big Mountain Road? Amanda - There is potential for future projects, they are currently working out on E Lakeshore Road. **North Fork** – Allen Chrisman and Richard Hildner – Interlocal coming up Feb 14 and they will set the date for the summer interlocal/Firewise Day (likely July 10<sup>th</sup>) as well as set a date for the fire training in June. Should know firm dates by the next FSF meeting. Completed annual Firewise Renewal.

**Richard Hildner,** Flathead Families for Responsible Growth had a gathering with professionals from fire and others in Whitefish. A suggestion about a QR code for fire updates, especially for people coming in from around the country. Several in the room think that MTFireInfo.org would be the best link to provide. \*Dylan will follow up with this\*a

Also, "overwhelmed by the number of fuel modification grants from all the different agencies and organizations if there a single source clearinghouse for grants and projects."

**Allen** – Share the short-term rental product that Henry worked on – share with Monica, share with the North Fork. Another QR code.

**Dylan Kopitzke** – Adding a Service Forester on the Stillwater Unit to work 93 corridor to Eureka and N Flathead County, sharing workload with Libby and Kalispell SFs. GNA in the Flathead is going strong and looking to add capacity, finished interviews with Community Preparedness Specialist for NWLO (includes Libby, Plains, Stillwater, Swan, and Kalispell) and will announce next month. Through HB883 Fire Protection Bureau is increasing fire preparedness and has approval to purchase new detection planes, increase number of T2 crews and improve performance of helicopters.

Jeremy Pris – Would like to give a shout out for Flathead County AQ doing a good job monitoring and communicating forecasts, opening up opportunities for people to burn during the winter months. DNRC fire is in training season, both taking and providing. Seasonal applications for firefighters are now open mt.gov will be hiring Feb-June. https://statecareers.mt.gov/

**Holly McKenzie** – Working with MSU extension, Flathead Conservation District and others on the Land Stewardship Series that will be hosted March/April. Will be hosted at the NMAR office behind Lilienthal (110 Cooperative Way) and will cap at 40 people. More to follow!
