Firesafe Flathead Meeting 2/21/2024 (Next meeting March 20th)

Our meeting was very well attended so much so that we will be looking of a larger conference room.

Flathead National Forest - Mike West

FNF purchased 2025 Home and Garden Show Case booth since the MT DNRC had purchased it for 2024.

850-acre Joint Chiefs thinning and piling contract awarded to Imperial Forestry. Primarily in the Stovepipe (west of Kalispell & Whitefish) and Good Creek areas. This is the last year of our current Joint Chiefs project.

Working with NRCS to apply for another round of Joint Chiefs 2025-2027. The new project area will overlap with our current project area except for excluding the Olney area and including Star Meadow, Somers, and Lakeside.

The National Forest Foundation (NFF) is in the process of hiring a forester to assist us with our Keystone agreement to reduce fuel on an additional 3500 acres within the wildland urban interface. NFF will begin to solicit contracts for this work soon.

Flathead Ridge Ranch – Caleb Dietz

Curious when MT DNRC grant awards will be announced so they know whether to submit the same or different application for consideration and plan work. Hoping to know about award decisions soon.

Natural Resources Conservation Service (NRCS) – Karli Becher

Record year with 70+ applications for fuel reduction projects. Working with Forest Service on 2^{nd} joint chiefs expanding west and south to lakeside/Somers and star meadows.

Flathead County - Lincoln Chute

Scheduling interface training with the LGFF and developing preplans, working to provide a presentation for the media to talk wildland fire and streamline communication during the fire year.

Working with the planning department to require fuel reduction work prior to final plat/approval of subdivisions.

Montana West Economic Development Forestry Assistance – Carrie Johnson

Foothills road grant funding fuel reduction project near completion. Good creek and Many Lakes grant applications were denied but reapplying in April. Somers and Lakeside grants

tentatively approved \$100K each, Kila tentatively approved \$250K. March 15th preproposal for all stewardship grants due.

North Fork Mitigation Committee - Allen Chrisman and/or Richard Hildner

Discussion around North fork road dust abatement funding request – would like DNRC and or Forest Service to contribute to the dust control annually. Concerned the current funding and plan to dust abate the NF road isn't going to begin until 2025. The county would like to see it begin in 2024 and not wait to start until 2025.

Montana DNRC Northwest Land Office – Dylan Kopitzke / Emma Merdovic

Share MTFireinfo.org QR. Olney Timber Sale and Haz Fuels Grant fuel break along Good Creek Road could be presented to land board in April. Lincoln Chute mentioned an opportunity to connect fuel break adjacent to and along the martin creek road identified during the east fork fire.

DNRC Kalispell Unit –Jeremy Pris / Kellie Kulseth

Gearing up for spring debris burning and spring fire season.

Big Mountain Fire District – Ben Devall

Brush pickup day in May. Looking into a resort tax to help support the Fire department and EMS as well as provide funding for projects adjacent to the community. March 5th Firewise event at the base lodge from 3-5pm.

Goosehead Insurance – Scott Countryman

Home inspector meeting went well; they want the realtor to request a home assessment to inspectors to engage. Would like the see accreditation for home inspectors. Local businesses may be willing to support financial backing to provided educational symposium for the community around home ignition zone, fuel reduction and better preparing community members for wildland fire.
