## 0900 - Welcome & Introductions

Ali Ulwelling, DNRC – We hosted the Living with Wildfire video and follow up presentation at FVCC AT139 on Tuesday with about 35 people in attendance. It was well received and the kickoff for the Land Stewardship Seminar series for 2022. In future planning, I will schedule MORE time for Rick and Lincoln to talk about their experiences as landowners are very interested in what they have to share.

**Bootjack Road** – The Good Neighbor Authority will have a 25-acre timber sale out for bid on Bootjack Road in the fall. This may be a good/high profile opportunity to talk about the GNA program, and the work occurring the WUI off Bootjack & Farm to Market Roads.

**Bark Beetle grant** proposals are due April 8<sup>th</sup> - This grant is for non-federal private lands (county, state) that are susceptible to bark beetles and would benefit from forest management.

**Forestry Expo** is coming up May 7—Are we interested in hosting a table/booth that day? Very popular event with a lot of people coming through! (Ali will be in Libby assisting with Risk Assessment training.)

**Home and Garden Show** – Tai Foley was there with info & his equipment this year and said there was a lot of interested in Home Ignition Zones, Firewise landscaping, thinning and fuels reduction. Recommended that we consider participating again in 2023. (In years past, Bill Swope and Ali would host a table and present.)

**Rick Connell, FNF** – Joint Chiefs' funding is getting underway on TLRD. There is potential to request additional funding, but we are figuring some of the Bipartisan Infrastructure Investment and Jobs Act funding as we go.

**Prescribed fire** – Spring is the time for smaller burns and pile burning. There are some planned throughout the forest, but the larger burns are generally planned for the fall. (Like Whitefish last fall.)

**Cross Boundary Coordination** meeting – Was held on March 3. Mike West did a great job of developing the invitation list, getting the speakers there, and facilitating the conversation. This is in an effort to better coordinate activities on the landscape, to be better aware of who is doing what where, and to work together in pre-planning.

**PODs** – <u>Potential Operational Delineations</u> are being developed by each District AFMO by hosting meetings and working closely with the partners in their area. Generally speaking, the process will identify potential control locations (natural or manmade features) and places where they can be connected with shaded-fuel breaks to improve opportunities for suppression in the event of a wildfire.

# Karli Becher, NRCS -

**Targeted Implementation Plans (TIPs)** 

- Ashley Lake: We have been funding projects here since 2020, accepting applications until 2024
- Little Bitterroot Lake: This year (2022) is the first year of funding, accepting applications until 2026
- **Wedge Canyon** (Trail Creek Rd area north to the Canadian border): this year (2022) is the first year of funding, we will be accepting applications until 2026

**Joint Chiefs**: funding started this year (2022) and we will be accepting applications until 2024; there could be opportunity for us to extend the project.

• They can accept applications at any time, the cutoff is unknown at this time but likely in October. Any applications we accept now would be for consideration for funding in 2023.

**Local Working Group** – Meeting is open to the public and being hosted March 31 from 1-3pm at FVCC AT139 (downstairs). They have not met in a couple of years and will be asking for resource concerns throughout the Flathead.

**Lori Woods**- Brought up the point that the grant program and opportunities for funding are confusing for people and it's difficult to find that information. She has brought this up in the past; what is the solution?

**Deb Starling, NW MT Hazardous Fuels** – A lot going on and working project by project to get things wrapped up. Burn season has been wet so finding it difficult to get piles burned. They are not currently taking on any new requests for funding but are receiving multiple calls each day, especially in the Lakeside, Many Lakes/Foothill Road, and Bigfork areas.

**Lincoln Chute, Flathead County** – He is working with the planning department and a fire chief subcommittee to review and update subdivision regulations. They would like to provide more consistent recommendations

regarding water supply and fuels mitigation and will need to review current subdivision regulations, agree on changes, make recommendations to the planning department, and get approval from the planning board.

Allen Chrisman, North Fork Fire Mitigation Committee – Has been building the agendas and plans for the North Fork Fire Hazard Reduction Field Trip on June 15 from 9:30am-3pm and the North Fork Firewise Day on July 13.

**Ben Devall, Big Mountain Fire District** – "It's still winter up here!" Their new landowner packets and website has been a success. They are planning to host a Fire Department open house the 3<sup>rd</sup> week of July and will focus on what it means to be "Firewise". They are purchasing some No Fireworks signs and have the Fire Danger signs and locations ready to go.

Richard Hildner – Is a resident of Whitefish, has been on the City Council, has a USFS career in wildland fire including being a fire behavior analyst (FBAN) on a Type 1 incident management team. He would like to support and help lead an effort to increase awareness of wildfire risk in the area north of Whitefish. We can start with Living with Fire video, host a presentation/conversation, provide information on the funding available, and things that landowners can do to make a difference. Richard is able to produce progression maps to help illustrate the wildfire risk and impact of a future fire in that growing WUI community. He's also like to see the short-term rental products that are being developed.

Matt Bishop, Stoltze – Meets with a lot of private landowners and also sees a need to better communicate what programs are available.
